(Mix 4 oz of Epsom salts, 3 TBSP of Miracle grow, 1/2 oz of liquid dish soap, and 2-1/2 gallons water, in a 5 gal bucket. Apply with sprinkling can or sprayer. You can supercharge the mixture by adding a few drops of “Neem” oil). Soya de Guaymas in San Carlos has Neem oil.)
